

END-USER LICENSE AGREEMENT FOR twoCalc

IMPORTANT: PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY.

This mikagika Ltd. End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and mikagika Ltd. for the mikagika Ltd. software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("software product").
